

Application for Membership and Electric Service

The undersigned, (hereinafter called "Applicant"), applies for membership in and for electric service from Volunteer Energy Cooperative, (hereinafter called "Cooperative" or "VEC"). At the premises located at the address shown below, upon the following terms and conditions, and hereby agrees: (1) To comply with and be bound by the articles for incorporation, the bylaws, rules and regulations, and policies of the Cooperative now in effect and as may, from time to time, be amended; (2) when electric energy becomes available, to purchase from the Cooperative all electric energy received; (3) that this instrument grants to the Cooperative an easement or rights-of-way over, on and under any property of the Applicant within the Cooperative's service area as provided in the Cooperative bylaws; (4) to obtain a grant of easement from any person or entity having any interest in property of Applicant; (5) to pay any and all expenses incurred by the Cooperative, including attorney's fees and court costs, for enforcement of any of the provisions of the application by the Cooperative; (6) upon acceptance of the application by the Cooperative, same shall constitute an agreement and contract, subject to being cancelled by either party in accordance with the bylaws and rules and regulation of the Cooperative. Applicant agrees to pay a bill of at least _____ .00 per month for a period of _____ months, regardless of the kilowatt hours consumed. By signing this application, the Applicant understands that VEC conducts a credit check of each new Applicant for service and may perform other credit checks periodically. The Applicant authorizes VEC to check his/her credit and employment history and to answer questions about the Applicant's credit history while a customer of VEC. The Applicant understands that providing the social security number is not required for service but will assist in making an informed judgment concerning this application and is needed to expedite its processing.
